

# **Copyright for JCU Post Graduate Students: a brief introduction**

Copyright materials are any text, image, computer programme, music score, chart, diagram, sound recording, film or video, or broadcast not owned by you.

#### Fair Dealing

Students can copy within limitations under the Copyright Act 1968 "Fair Dealing" provisions for the purposes of study or research.

The University has a number of Copyright related licences for the authorised usage of materials for teaching. Student's use of Copyright materials is not covered by the licence agreements.

Copying under "Fair Dealing"		
Articles from Journals, Magazines or Newspapers (Print or Electronic)	1 Article from that issue	If the same subject matter, possibly more. If unsure, check with Infohelp.
Books (Print or Electronic)	10% or 1 Chapter	Which ever is greater.
Music/Movies (Any Format)	Not at all unless: it is not commercially available, and reasonable part for your study.	If unsure, check with Infohelp.
Note: "Fair Dealing" does not include copying of computer software.		
This is a summary only, if in doubt, check with your School or Faculty Librarian or the University Copyright Officer.		

#### **Creative Commons**

An alternative to copyright materials. Creators make their works available for use with limited restrictions. See: <u>http://creativecommons.org.au/</u>

Use of University equipment, facilities and/or premises for a purpose that infringes Copyright is forbidden.

#### Plagiarism

Be aware that the University requires all ideas acknowledged. This includes the author and the source of the information. This is important to note for paraphrasing.

# Referencing

Check with your School or Faculty for the relevant referencing style required for submitted work.

## **Copying Materials You Have Purchased**

The Australian Government is currently reviewing laws in relation to copying (e.g. TV shows for later viewing, music you have purchased and wish to transfer to a different format). At this time, it is illegal to copy materials other than under the "Fair Dealing" section of the Copyright Act 1968.

## **Computer Programmes**

Programmes are not to be copied unless permission is given in the vendor's licensing agreement.

## Notices

Students must comply with Copyright related notices placed near photocopiers, printers and computers.
