JCU's joint Master of Professional Accounting – Master of Business Administration (MPA – MBA) degree can be completed in two years. The degree is designed for students who intend to work as professional accountants and in senior management positions. Joint degrees qualifications are in high demand in Australia and overseas.

Our accounting subjects are offered after hours at JCU Townsville with intensive weekend workshops. You may also study part-time.

Students who exit the course prior to completion, and have completed the relevant number of credit points and appropriate subjects, may be eligible to receive one or more of the following awards:

- Graduate Certificate of Accounting
- Graduate Certificate of Business Administration
- Graduate Diploma of Accounting
- Graduate Diploma of Business Administration.

ENTRY REQUIREMENTS
