


Following the successful 1st International Conference on Business, Economics, Management, and Sustainability (BEMAS) in July 2021, the Centre for International Trade and Business in Asia (CITBA) at James Cook University-Australia at the College of Business, Law, and Governance at James Cook University is pleased to announce the 2nd International BEMAS conference on 1-3 July 2022. CITBA aims to create a platform for academics, researchers, practitioners and students to share their research findings with other global experts.

Coronavirus Information

As the COVID-19 outbreak evolves around the globe, and with international travel restrictions still in place, we have opted for virtual conference that would allow for remote participation. In order to offer participants a more flexible way to experience the conference at their own pace and timeline; presentations will be either in the form of live streams or pre-recorded video presentations. Background reading materials such as full papers, posters, and source files will be also provided to participants prior to the conference.

Conference Themes and Topics

Population movements into cities have accelerated over the past few decades, with more than half of the world's population now living in urban areas. The urban population has grown from 751 million in 1950 to 4.2 billion in 2018 (United Nations, 2018b). North America is the most urbanised region in the world with 82% of its population living in urban areas, Latin America and the Caribbean comes in second place with 81%, Europe and Oceania follow suit with 74%, and 68% in that order. The more balanced regions include Asia, with almost 50% urbanisation and Africa, with 43% of its population living in urban areas (United Nations, 2018a). This rapid urbanisation places an enormous demand on infrastructure, service sectors, and natural environments, including land. Furthermore, the new millennium has witnessed widespread and frequent external shocks (including but not limited to financial shocks, unsustainable growth, and public health emergencies) resulting in massive economic losses, depressions, and loss of lives (Chaiechi, 2020a). Simultaneously, the orthodox methods of addressing external risks are no longer adequate, as they fail to account for evolving industries' composition, adaptive and inherent resilience, and new comparative advantages and skills (Chaiechi, 2021b).

This ongoing urbanisation and increasing intensity and frequency of external shock show the importance of building resilient economies capable of dealing with complex external financial and public health shocks and disturbances. And while most growing cities are beginning to demonstrate dedication to integrating sustainable development goals (Chaiechi, 2021a), building urban economic resilience remains a significant challenge.

Author's Guideline

Presentations

All presentations are virtual for this conference. Presentations are either live stream or pre-recorded video presentations. Please note that pre-recorded presentations are to be created by the authors. Further information on creating the video will be sent following registration. The length of the live stream or pre-recorded presentations should not be longer than 20 minutes.

Papers

Accepted full research papers, practitioner papers, scoping/systematic literature review papers, and case studies shall have a maximum length of 6,000 words (the word count limit excludes tables, figures, and references list). Accepted research notes shall have a maximum length of 3,500 words (the word count limit excludes tables, figures, and references list).

General in-text styles: Times New Roman 12 point, regular. Line spacing 1.5, one line space for new paragraph (do not indent the first line of paragraphs). Footnotes: Times New Roman 10 point, regular.

Language

All submitted articles must be written in English. Both British and American spellings are accepted, as long as one spelling is used consistently throughout the text. Authors are strongly advised to ensure the grammatical correctness of their paper prior to submission. Papers with significant grammatical errors may be returned without review.

References

All papers shall be submitted using the APA reference style. APA style requires both in-text citations and a final references list. For every intext citation, there should be a full citation in the reference list and vice versa.

Abstract Submission

abstracts are submitted through our Online submission platform on the conference website.

- Abstracts must be limited to 250 words. The abstract must be submitted through the online submission system
- Author details, including email addresses and affiliations, must be included
- Five to six keywords must be provided
- Abstracts must be text-only. Images, graphs, or tables not to be included
- Authors of accepted abstracts will be asked to submit a full paper for a double-blind peer-review process.

These crises adversely affected businesses, communities, and economies globally, resulting in social and economic disruptions. In a global-scale emergency such as the COVID-19 pandemic, even strong economies demonstrated a lack of resilience and adaptive capacity. Equally, for businesses and communities, the impacts of these shocks have evidenced the need to pivot thinking, repurpose resources and be resilient. The effect of these crises is extended to industries, occupations, and livelihoods.

Building economic resilience requires efforts and collaboration from both the public and private sectors. The private sector, spanning small and medium enterprises to national and multinational enterprises and academic institutions, has a wealth of knowledge and assets that could be productively channeled to improve resilience during natural disasters and public health emergencies. The private sector's resilience, responsiveness, and ingenuity are essential preduring and post-crisis to reduce risk, provide agility, and reduce response time and cost. Furthermore, the collaboration between the public and private sectors can help leverage the allocation of resources, knowledge spillover, and dynamics to ensure communities can prepare for, endure, and recover from disasters.
