Launch of the ILNP Victorian Report

The ILNP *Victorian Report* (2013) was launched at the Victorian Aboriginal Legal Service (VALS) in Melbourne on 29 November 2013. Our project partners in Victoria, VALS and Victoria Legal Aid (VLA), formally launched the report. ILNP researchers presented key research findings. The event was well attended by members of the public, including a range of stakeholder organisations and media.¹ Thank you to our Victorian ILNP project partners for their contributions to the *Victorian Report*, including their assistance with the launch. Thanks also to all other persons and organisations in Victoria who have provided valuable material for the Report.

The *Victorian Report* identifies significant civil and family law need in the Indigenous communities visited by the ILNP in 2012-2013. Priority legal issues in Victoria are broadly similar to those identified in the ILNP *NT Report* (2012).² Overall, **housing**, and in particular **tenancy**, has again emerged as the most prevalent legal issue in focus groups and stakeholder interviews, with **41.8%** of all focus group participants identifying having had a problem in this area. Other priority areas of civil/family law were **discrimination (29.2%)**, **neighbourhood issues (26.7%)**, **credit and debt (and consumer) issues (32.4%)**, **social security, child protection, victims**

compensation and wills.

The *Victorian Report* identifies significant gaps in Indigenous access to justice with respect to civil and family law problems. Only just over one in five Indigenous focus group participants in Victoria who identified having had a housing related problem, for instance, had sought legal advice or assistance in response. Slightly over one in ten who had experienced problems in relation to discrimination and social security had sought assistance or advice. The Report sets out community and stakeholder perspectives on suggested strategies to reduce these gaps and to increase Indigenous access to justice. These include an increased focus on and resourcing of civil and family law service delivery to Indigenous communities across the whole of the State, enhanced Indigenous knowledge of civil and family law rights, including through delivery of CLE, and

more effective partnerships between lawyers and non-legal and legal services.

The [ILNP Victorian Report](#) is available for download on the ILNP website.

The ILNP has also produced a **short animated film** summarising the research findings from our *Victorian Report*. This video is intended to improve access to research findings for Indigenous communities and project stakeholders, to contribute to increased Indigenous knowledge of civil and family law, and to link communities in need with relevant legal services. It presents in A/V format some of the experiences of civil and family law problems arising in the Victorian communities, as recounted to us by stakeholders and focus group participants during our travels.

ILNP Jurisdictional Reporting in Other States

We are now working on ILNP jurisdictional reports and short animated films for Queensland and Western Australia. These will be released and published on the ILNP website in 2014. Stakeholders will be notified by email at the time of publication.

ILNP FIELDWORK

Over the last 7 months the following fieldwork (both focus groups and stakeholder interviews) has been completed.

- All fieldwork has been finalised in **Victoria**.
- In WA, fieldwork has been conducted in **Balgo, Fitzroy Crossing** and **Wyndham** (and **Kununurra** for Wyndham; **Halls Creek** and **Broome** for Balgo and Fitzroy Crossing).
- In Qld, fieldwork has been conducted in **Rockhampton, Cairns** and **Pormpuraaw**.

We again thank, as always, all of those who assist so ably with our fieldwork: local focus group coordinators, focus group participants, stakeholders who participate in interviews and project partners in Qld and WA who help out with logistics, amongst many other things.

In particular, the Aboriginal Legal Service in WA (ALSWA) has to date accompanied the ILNP on all of our WA field trips: providing legal assistance to Indigenous focus group participants who need help with civil/family law

issues, conducting CLE, and more generally letting communities know that they can get legal help with a range of *non*-criminal legal issues. So often, Indigenous communities we have visited associate legal services with criminal law problems. It has been great to have this service working so closely with the project.

We note that whilst similar civil and family law problems are identified as arising in many ILNP communities, legal issues that are particular to specific jurisdictions are also evident. In Qld and WA these include, for instance, traditional adoption in parts of Qld (for example, its relationship with mainstream family law) and problems with the WA stolen wages compensation scheme (time period for application, eligibility, amounts of compensation). These and other issues will be discussed in detail in our jurisdictional reports for WA and Qld.

As at January 2014, there are 5 remaining ILNP communities: **Tjuntjuntjarra, Roeburne, and Narrogin in WA** and **Roma and Charleville in QLD**. A few interviews also remain in Perth and Brisbane. We are aiming to complete all ILNP fieldwork in these communities by mid 2014. Dates for visits to these communities will be posted online on our blog, website and Facebook page.
