

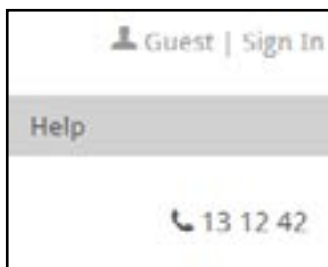
## QUICK REFERENCE GUIDE



### LAWLEX PREMIUM - LEGISLATION ALERT PROFILE

Lawlex Premium Legislation Alerts provide you with plain English summaries of changes to legislation according to your customised profile selections. Alerts are sent by email within 24 hours of publicly announced changes to or introduction of new legislation.

## SIGNING IN



Visit [lawlex.com.au](http://lawlex.com.au) and **Sign In** on the right-hand side of the page by entering your username (email address) and password. Your password can also be sent to you by clicking **Forgot your password?**

You will stay signed in unless you manually sign out.

## CREATING YOUR PROFILE



### Step 1: Subjects of Interest

Select **Subjects of Interest** from the Legislative Alerts panel on the Lawlex home page.



First, select the jurisdictions you wish to track and then expand (click the + key) and select the categories and subcategories you are interested in. Selecting the subject areas relevant to you will ensure that you receive new principal legislation (Bill, Assent and Regulation) alerts in these areas.

Click **Save and Continue** to save your selections. A pop up window will ask you to confirm your selections. Click **Confirm** and move to **Step 2: Legislation**.

## Step 2: Legislation

The subcategory selections you made on Step 1 will be automatically expanded on the **Legislation** tab so that you can easily view the legislation in that area. You can also expand other subject areas here and select additional titles that are relevant to you, or use the **Alphabetical List**. Your jurisdiction selections from Step 1 are also carried through to Step 2.

Select the specific legislation that you need to keep track of to receive amending legislation alerts. Make your selections by placing a tick in the box next to each title.

Select the legislation that is of interest to you.

## MODIFYING YOUR PROFILE

Modify your **Current Selections** at any time by de-selecting the subject categories or legislation titles and clicking **Save**.

Removing a subject of interest means that you will no longer receive new Bill, Assent and Regulation alerts in that area. Removing a specific legislation title means that you will no longer receive amendment alerts for that legislation.

Add to your profile by selecting the relevant tab at the top of the page – **Subjects of Interest** or **Legislation**. If you are unsure of your location, the tab for the page that you are on is selected and displayed in white.



You can also manage your profile directly via the email alerts.

**[Liquor Licensing \(Fees\) Regulations 2015 No. 64 \(Tas\)](#)**

The Liquor Licensing (Fees) Regulations 2015 No. 64 (Tas) have been made under the authority of the Liquor Licensing Act 2005 (Tas).

According to the explanatory note, the Regulations:

(a) prescribe fees payable under the governing Act; and  
 (b) rescind the Liquor Licensing (Fees) Regulations 2005 No. 112 (Tas) and the Liquor Licensing (Fees) Regulations 2005 No. 112 (Tas).

The Regulations will commence on 9 September 2015.
